News Release: 2014 State Accountability Ratings

For Immediate Release

(August 8, 2014) – Crowley ISD has exceeded state standards in all four of the key academic indexes in the 2014 State of Texas Assessments of Academic Readiness (STAAR). Results released today by the Texas Education Agency show the District and 18 of its 21 tested campuses have been rated at the top level of "Met Standard" and achieved 13 titles of academic "Distinction Designations."

This is the second year that the state is using its performance index-based approach to academic accountability. The 2014 ratings apply one of two labels to districts and campuses: "Met Standard" or "Improvement Required" based on performance in four key academic indexes.

- ✓ Index 1 (Student Achievement) Crowley ISD "Met Standard"
- ✓ Index 2 (Student Progress) Crowley ISD "Met Standard"
- ✓ Index 3 (Closing Performance Gaps) Crowley ISD "Met Standard"
- ✓ Index 4 (Postsecondary Readiness) Crowley ISD "Met Standard"

Campus Summary:

- 18 of the 21 rated campuses in Crowley ISD "Met Standard" by meeting all applicable state index targets.
- 96% of the required campus performance indexes (77 of 80) were met or exceeded by Crowley ISD students.
 - 100% of Crowley ISD's rated campuses (21 of 21) exceeded state standards in Index 1 (Student Achievement).
 - 94% of Crowley ISD's rated campuses (16 of 17) met or exceeded state standards in Index 2 (Student Progress).
 - 90% of Crowley ISD's rated campuses (19 of 21) exceeded state standards in Index 3 (Closing Performance Gaps).
 - 100% of Crowley ISD's rated campuses (21 of 21) exceeded state standards in Index 4 (Postsecondary Readiness).

To be rated as "Met Standard," each campus must meet all applicable index targets. If any one of the index targets is missed, the campus rating is "Improvement Required." Among Crowley ISD's campuses, 2 out of 4 high schools were rated as "Met Standard," 3 out of 3 middle schools were rated as "Met Standard," 4 out of 4 intermediate schools were rated as "Met Standard," and 9 out of 10 elementary schools were rated as "Met Standard." Also at the campus level, 7 Crowley ISD schools earned a combined 13 titles of academic "Distinction Designations":

- ✓ Academic Achievement in Reading/English Language Arts: 3 campuses
- ✓ Academic Achievement in Mathematics: 2 campuses
- ✓ Academic Achievement in Science: 1 campus
- ✓ Top 25% Student Progress: 4 campuses
- ✓ Closing Performance Gaps: 2 campuses
- ✓ Postsecondary Readiness: 1 campus

"These state accountability ratings are just one of the many tools we use in Crowley ISD to track student achievement," Superintendent Dan Powell said. "We are now using this latest data to identify key areas of intervention and enrichment for our students."

"Crowley ISD has reason to celebrate and our teachers, students and parents should be proud of the academic gains being made in classrooms across our District," Powell said. "But, these results highlight specific needs in our schools and we are dedicated to taking every Crowley ISD student to the next level. We must be especially committed to closing the performance gaps among our minority and economically disadvantaged students because in Crowley ISD, our mission is to provide excellence in education so that ALL students achieve their full potential."

Improvement Required

- As per Table 1, three schools were rated as Improvement Required: Bess Race Elementary, Crowley High School and North Crowley High School.
- These three Improvement Required schools missed only one of the applicable targets. Bess Race Elementary School missed Index 2. Crowley High School and North Crowley High School missed Index 3.

BACKGROUND: FEATURES OF THE STATE ACCOUNTABILITY SYSTEM

- The focal point of each index includes:
 - Index 1 (Student Achievement) scores on all tests in the accountability subset are at or above Level II:
 Satisfactory, keeping in mind that some students may contribute multiple test scores to the indexes (this index most closely resembles the previous state accountability system)
 - Index 2 (Student Progress) performance on each of the tests in the accountability subset meets or exceeds progress expectations across up to 10 student groups, with extra weight given to the scores that exceed progress expectations
 - Index 3 (Closing Performance Gaps) scores for economically disadvantaged students and up to the two lowest performing ethnic subgroups in 2013 were at or above Level II: Satisfactory in 2014 (with extra weight give to the students that score at or above the "Advanced Standard")
 - Index 4 (Postsecondary Readiness) students in up to 10 groups graduated on time and students in seven racial/ethnic groups graduated on the Recommended and Distinguished/Advanced plans and demonstrated postsecondary readiness
- Only campuses that are rated as "Met Standard" are eligible to receive Academic Achievement Distinction
 Designations. A maximum of seven such Distinction Designations are available in 2014. Each of the seven
 distinctions examines performance relative to a TEA-prepared comparison group of 40 demographically similar
 campuses from across the state.
