BOARD ACTIONS

Approved **Budget Amendments** to send Megan Dixon, Inspire Academy dean, to a conference.

Approved the opening of an Employee Child Care Center at Jackie Carden Elementary School in August 2017. The total initial start-up costs are estimated at \$598,494, which includes facility renovations and classroom furniture and equipment funded from capital bond dollars, as well as \$6,879 from general fund. First-year expenses are estimated at \$388,449 and estimated revenue is projected to be \$464,453.

The mission of the Crowley ISD Child Care Center will be to provide high quality child care for employees of the district to attract employees and lessen turnover and absenteeism. By providing a child care program for employees, the district will strive to assist employees in building strong families and a stable workforce.

SUPERINTENDENT REPORT

Dr. Dan Powell is taking a medical leave of absence beginning Feb. 24 and resigning as superintendent as part of an agreement reached with the Board of Trustees. During his report, Dr. Powell discussed his departure from Crowley ISD after serving seven years as superintendent. He said serving as the superintendent in CISD has been a wonderful opportunity for him.

"I want to express how profoundly proud and blessed I have been to be able to be superintendent of this school district," Dr. Powell said. "I'm so proud of the many, many things that this group in this room and your colleagues in the 23 schools and the other facilities across the district have achieved."

Dr. Powell discussed the district's obligation in taking students, "from where they are to the very, very pinnacle of where they might be — and the magic in that is we never know what they might be able to do and what they can accomplish."

He also praised the incoming interim superintendent, who he has worked with previously.

"I know she will continue to bring out the greatness in this staff and in this community as interim superintendent as she's done before," Dr. Powell said. "I'm going to spend my retirement years watching all the great things you do."
