House Bill 1842 provides that once the Board of Trustees has completed the Public Hearing and decided to move forward with District as a District of Innovation process the Board must appoint a committee to develop the local innovation plan in accordance with Section 12A.003 of House Bill 1842.

Once the District Advisory Committee develops the Local Innovation Plan the plan will be posted on the district website for thirty days and a public hearing will be held to solicit community feedback. During the thirty day posting period the plan will also be submitted for informational purposes to the Commissioner of Education. Following the public hearing the District Advisory Committee will vote on the plan. If approved by a majority vote the plan will then go to the Board. The proposed plan may be adopted 'as is' by an affirmative vote of two-thirds majority of the Board of Trustees.
